### What does the Fund invest in?

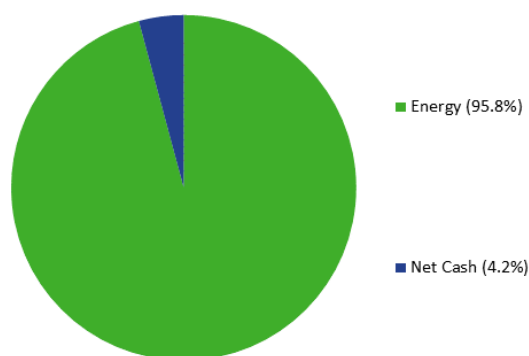
The Fund invests in equities of all market capitalizations in Canada's resource sector using a value methodology commonly referred to as "growth at a reasonable price". This approach means targeting resource companies that (a) have a strong management team; (b) are trading below intrinsic value or at discount to peers; and (c) have above average growth prospects. The Fund will invest in companies with a high potential for share price appreciation that can be realized from a revaluation of the company, growth from a developing a resource prospect, and/or from exposure to rising commodity prices. This Fund is classified as an Energy Equity fund, thus it must invest at least 90% of its equity holdings in the securities of companies in the Energy sector.

The charts below give you a snapshot of the Fund's investments on March 31, 2019. The Fund's investments will change.

### How risky is it?

The value of the Fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

### Risk rating

NCM Asset Management Ltd. has rated the volatility of this Fund as **high**.

This rating is based on how much the Fund's returns have changed from year to year. It doesn't tell you how volatile the Fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

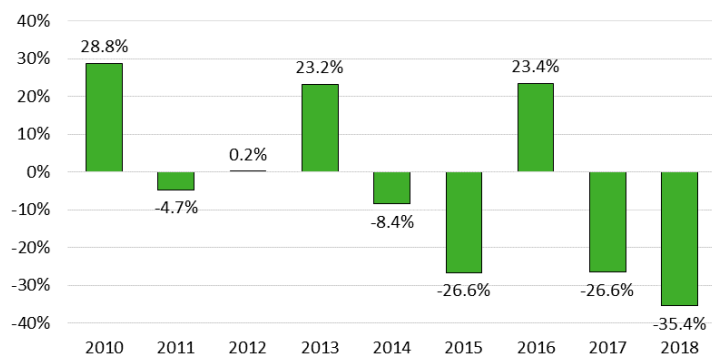
Like most mutual funds, this Fund doesn't have any guarantees. You may not get back the amount of money you invest.

### How has the Fund performed?

This section tells you how the F Series shares of the Fund have performed over the past 9 calendar years. Returns are after expenses have been deducted. These expenses reduce the Fund's return.

#### Year-by-year returns

This chart shows how the Series F shares of the Fund have performed over each of the past 9 calendar years. The Series decreased in value in 5 of the last 9 calendar years. The range of returns and change from year to year can help you assess how risky the Fund has been in the past. It does not tell you how the Fund will perform in the future.



#### Best and worst 3-month returns

This table shows the best and worst returns for the Series F shares of the Fund in a 3-month period over the past 9 calendar years and from January 1, 2019 to March 31, 2019. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

#### Average return

As at March 31, 2019, a person who invested \$1,000 in the Fund at its inception now has \$882.53 This works out to an annual compound return of -1.3%.

### Who is this Fund for?

This Fund is suitable for investors who:

- Are enrolled in a fee-for-service or wrap account program
- Wish to invest in Canadian and foreign resource equities
- Want the potential for long term capital appreciation
- Are comfortable with high investment risk (i.e. can tolerate significant volatility in the market value of your investment)

### A word about tax

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

### How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series F shares of the Fund. The fees and expenses – including any commissions – can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

#### 1. Sales charges

No sales charges or commissions are applicable to this series of the Fund.

#### 2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the Fund's returns. As of September 30, 2018, the Fund's expenses were 1.86% of its value. This equals \$18.60 for every \$1,000 invested.

#### Performance fee

The Fund will pay a performance fee to the Manager if the series return of the Fund exceeds the return of the applicable market index during the same period. The performance fee is determined by taking 20% of the excess return and multiplying it by the average series net asset value during the period.

The performance fee will only be paid if the series return is greater than zero since the last time the performance fee was paid and if the series has outperformed the applicable market index since the last time the performance fee was paid.

#### More about the trailing commission

No trailing commission is paid in respect of this series the Fund.

#### 3 Other fees

You may have to pay other fees when you buy, hold, sell or switch shares of the Fund.

Fee	What you pay
Short-term redemption fee	2% of the cost of the shares you redeem within 30 days of the original date of purchase. This fee is charged by the Manager.
Switch Fee	Your representative's firm may charge you a fee if you switch to another series of the Fund or to another fund within the NCM Group of Funds.
Fee-for-service program	Series F shares are intended for investors who are participants in a fee-for-service or wrap account program sponsored by certain securities dealers. You pay a fee to your representative to participate in such a program.

### What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- a. Withdraw from an agreement to buy mutual funds within two business days after you receive a simplified prospectus or Fund Facts document, or
- b. Cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
