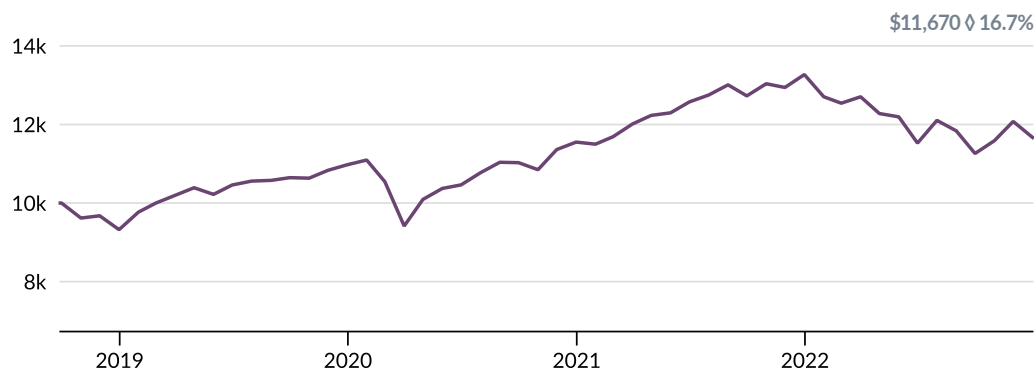

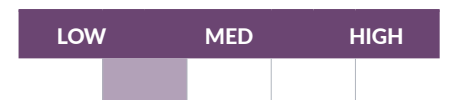
VALUE OF \$10,000 INVESTED AT INCEPTION

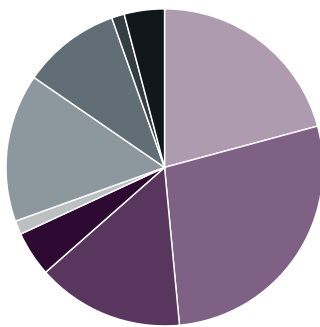

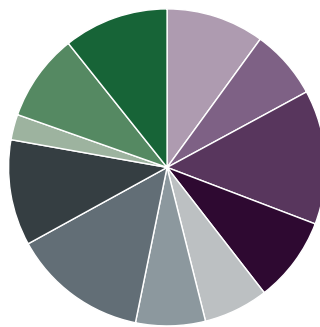

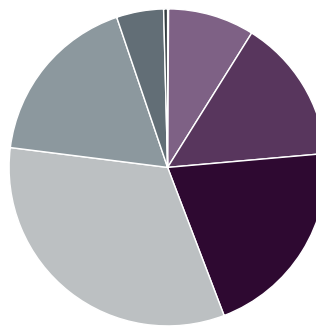
